Lessee assumes all responsibilities for equipment while out of possession of lesser and promises to return such equipment to Center Stage Party Rentals in as good condition as it was at the effect date of the lease, normal wear from a responsible use is expected. Lessee shall be liable for any loss, theft, damage or destruction of leased property.

All equipment loss or damaged beyond repair will be paid for by the lessee at the regular replacement price and all damaged equipment which may be repaired will be repaired by the manufacturer on the return thereof and the cost for such repairs shall be paid by the lessee. Accrued rental charges cannot be applied against the purchase price or cost of repairs of such damage or lost equipment. All cartage charges must be borne by the lessee.

Scheduled rental rates begin when equipment leaves the shop and continues until returned hereto. In the event the lessee desires to extend the lease, Center Stage Party Rentals must be notified immediately to obtain approval in writing for said extension.

I agree that all charges for rental, damage, or material will be paid, and that all collection fees, attorney fees, court costs, or any expense involved in the collection of these charges will be borne by me in the court of the county in which indebtedness is incurred.
